Appointees to be paid a per diem for attending meetings and educational seminars

Township Board members to be paid a per diem for attending meetings and educational seminars if they meet one or more of the following requirements.

1. The meeting and/or and educational seminar is other than the elected officials job description in the red book.
2. The meeting and/or and educational seminar is located outside of the County.
3. The meeting and/or and educational seminar lasts 2 or more hours.

Appointees and Board Members to be paid mileage for attending meetings and educational seminars if they are held five or more miles from Constantine.
